The President Signed 2013 NDAA January 3, 2013

SPACE-A TRAVEL: The 2013 National Defense Authorization Act includes expanded space-available travel for the National Guard. Space-available travel on DoD aircraft will be open to more reserve component members, gray area retirees, dependents and certain widows.

PHARMACY: Beginning February 1, 2013, mail-order prescriptions for a 90-day supply would be free for generics, \$13 for brand-name drugs and \$43 for drugs not on the approved list, known as non-formulary drugs. At retail pharmacies, a 30-day supply of drugs would be \$5 for generic, \$17 for brand name and \$44 for non-formulary drugs. These co-pays will be allowed to increase by no more than the retirement COLA each year.

TCFL eligible beneficiaries (not before April) will be required to try using either military pharmacies or the mail-order system for refills of maintenance medications for at least one year. After a year, they can opt out and go back to using the retail system for all refills if they choose. There will probably be a delay in implementing this portion of the program as it begins to enforce home delivery for seniors 65 and over. It is established requirements to ensure no one is turned away at retail pharmacies without enough medication to last until a mail-order account is established for them. It also gives DoD authority to waive the requirement for selected medications (e.g., many generics likely will be exempted, because they cost no more in retail pharmacies) or beneficiaries (e.g., nursing home patients).

CONCURRENT RECEIPT: The glitch for concurrent receipt has been fixed. The formula underpaid CRSC for combat-disabled military retirees. Proper credit payments became effective January 1, 2013. Most affected are those combat-disabled who were forced into medical retirement with less than 20 years of service. The formula has been so complicated and varied by length of service and VA disability rating so it was impossible to specifically know who was getting paid correctly under the old law. There's no provision to provide corrected payments for prior years. BUT--The push has to begin all *over again this year to end the SBP/DIC offset and end the offset of military retired pay and VA disability pay for those retirees who still are not getting both payments (this includes the widows receiving SBP/DIC).*

Medicare/TRICARE payment cuts for physicians has been pushed back one year. (Of course this decision came so late that many physicians have dropped out of the program.) Then we will be going through this whole thing AGAIN! Write your congressional members and ask for a LONG TERM MEDICARE payment solution. This shouldn't be coming up every few months or each year! Physicians are dropping Medicare/TRICARE patients and it is difficult to find a physician in your area.

The Home Energy Tax Credit which expired December 31, 2011 has been extended!

TITLE IV—ENERGY TAX EXTENDERS, SEC. 401. Extension of Credit for Energy-Efficient Existing Homes.

Extended to December 31, 2013.

FROM EANGUS PRESIDENT JOHN HELBERT

In late October, the EANGUS Executive Council met in Washington, D.C., to evaluate our finances through the end of the year and plan our budget and goals for 2013. The good news is our revenues increased in 2012 by more than \$300,000. The bad news is we took a significant loss on our conference in Long Beach. But our loss was nothing compared to conference losses by other major military associations. The backlash from the GSA scandals caused some of them to lose millions of dollars, but we are in great shape moving into 2013.

Next year we are anticipating further increases in revenues across the board. Our new Director of Business Development, Steve Fink, will be handling corporate partners, New Patriot advertising and conference sponsorships. Steve was the workhorse who generated the majority of the content in our new 2012–2013 National Guard Almanac and Education Guide, and we have high expectations for him for next year.

Steve's addition to the National Office means that we now have eight employees, double what we had in 2010. Each staffer has a great skill set, and when you add a contract employee, interns and volunteers, our building is humming with activity.

The addition of a director of business development is significant for another reason. By shifting those responsibilities to a new position, our executive director can fully turn his attention to significantly increasing membership. Together, we are developing a comprehensive plan that can increase our membership by 20 percent or more in 2013—from 50,000 to

60,000 members. Better still, the core focus will be recruiting newly promoted E-5s and E-6s, infusing our growth with long-term members that we intend to retain.

In the coming months, we will be rolling out new benefits of membership and new recruiting tools for state associations. We have been working for two years to build up a series of benefits, incentives and legislative victories that will make our enlisted troops WANT to join EANGUS for the sheer value of it.

One of those benefits is New Patriot Magazine. We have transformed it from a quarterly newsletter into a professional journal. This summer, New Patriot was selected for an APEX Award of Excellence (left). I'd like to tip my hat to Immediate Past President Roger Hagan for championing the upgrade, and to GLC Custom Media (our publisher) for doing the lion's share of the work on design and content development. We are all proud of our new New Patriot, and I assure you, it will just keep getting better.

All the best to you and your family in 2013.

THE FISHER HOUSE PROGRAM

The Fisher House program is a unique private-public partnership that supports America's military in their time of need. The program recognizes the special sacrifices of our men and women in uniform and the hardships of military service by meeting a humanitarian need beyond that normally provided by the Departments of Defense and Veterans Affairs. [There are 58 Fisher Houses.]

Because members of the military and their families are stationed worldwide and must often travel great distances for specialized medical care, Fisher House Foundation donates "comfort homes," built on the grounds of major military and VA medical centers. These homes enable family members to be close to a loved one at the most stressful times - during the hospitalization for an unexpected illness, disease, or injury.

There is at least one Fisher House at every major military medical center to assist families in need and to ensure that they are provided with the comforts of home in a supportive environment. Annually, the Fisher House program serves more than 17,000 families, and have made available over four million days of lodging to family members since the program originated in 1990. By law, there is no charge for any family to stay at a Fisher House operated by the Department of Veterans Affairs; and Fisher House Foundation uses donations to reimburse the individual Fisher Houses operated by the Army, Navy, and Air Force. **No family pays to stay at any Fisher House!**

In addition to constructing new houses, Fisher House Foundation continues to support existing Fisher Houses and help individual military families in need. We are also proud to administer and sponsor Scholarships for Military Children, the Hero Miles program, and co-sponsor the Newman's Own Award.

PAPER SAVINGS BONDS



As you may know, as of January 1, 2012, you could no longer purchase U.S. Savings Bonds at your local bank or credit union. Not only that, you could not buy paper versions of the bonds — with one exception. *The only way left to purchase a paper Savings Bonds is to use your tax refund.* You'll need to file Form 8888, Allocation of Refund (Including Bond Purchases) with your 2012 federal income tax return, so

you can tell the Treasury Department that you want to use all or part of your tax refund to buy paper I Bonds. You can purchase up to \$5,000 in I Bonds through the tax refund program.


